### 6. Treasurer's Report and Presentation of Accounts for 2018/2019

Michael J W Morgan, Vice Chairmen presented the accounts, copies of which had been circulated for the meeting.

The Vice Chairman advised that the previous financial year saw a small increase in income from £3586.01 in 2017/18 to £4207.19 in 2018/19 due to the increase in membership fees charges. The overall balance of the Group's accounts stood at £17462.68 for 2018/19 against £16240.28 in 2017/18.

Expenses rose in 2018/19 due to room hire and refreshment costs for the Group meetings. In summary the Group is financially stable and expenditure for the coming year is forecast to be roughly in line with the previous year.

#### 7. Chair's Annual Report as Presented by Vice-Chair Michael J W Morgam

A very warm welcome to you all to our AGM.

Our group is now in its 78<sup>th</sup> year and whilst the hazards faced in 1941 are remarkably different to those in our current workplaces, the groups commitment to promoting a safer and healthier work life remains.

We are moving towards more technology based solutions for our members. Over the past year we have introduced booking on to events through Eventbrite as well as introducing PayPal. Our social presence continues to grow through LinkedIn and Facebook but most importantly we continue to strive for the title of friendliest safety group. Over the past few years the UK has seen a decline in local safety groups, not just in attendance but sadly two that we know of have closed after many years of support to the safety community. With increased work, pressures of everyday life and worries for the future many people no longer are finding the time to invest in themselves so I thank you all for your continued attendance and contributions to the sessions.

I would also like to acknowledge the ongoing support from Unison who provide our location at a reduced cost and Zurich for hosting our Fire Day. I would also like to extend special thanks to our President, Lord Brougham & Vaux who couldn't be with us today.

I would now like to add my biggest thank all our volunteers, by which I mean our hardworking committee who contribute so much and without whom the group would not function.

Mel, Belinda, Abi, Claire, Fareed, Michael and Tracey. I would at this point like to ask Fareed to step up and join me. This is Fareed's last AGM as a committee member and we would like to formally recognise his personal commitment and tireless work for the group.
